Under certain conditions the material may become combustible because of the ease of ignition which occurs after the material reaches a high specific area ratio (thin sections, fine particles, or molten states). Others oxidise so slowly that heat generated during oxidation is dissipated before the metal becomes hot enough to ignite. #### **Respiratory protection**
